In his new duties, Carpenter will work closely with Conference Chair **Don O'Neal**. Both promise something of interest to all, including the traditional Welcome Reception—this year featuring a Taco bar—the Merit Awards Banquet on Thursday night and a Sayonara Business Brunch Friday morning.

Once again we will meet jointly with the senior leadership of

Public Affairs from commands all over the world.

Carpenter said he and Don would do all they could to hold down the price for this year's conference. "As anyone who travels knows," he said, "hotel prices are skyrocketing. Unfortunately, unless we want to be stuck out in the 'boonies' somewhere we have to pay the going rate. In the case of the Menger, the hotel nightly rate will be \$112. On the plus side, we have negotiated meal prices so that we will offer a member-only registration rate of \$120." (Ed. Carpenter encouraged all attendees to both register early and make their hotel reservations by July 18 to avoid the problems experienced in Los Angeles where we had to add two hotels to handle the overflow. (See Info on P-11)

Denig Award: Jim Lehrer

Calling it an award he would always treasure, PBS NewsHour anchor Jim Lehrer accepted his overdue Brig. Gen. Robert L. Denig Memorial Distinguished Memorial Award at a luncheon November 28 at Ft. Meyer in VA.

The luncheon, put together by Board member Don Knight and ably assisted by Jim Kyser, was attended by 58 members and guests, including several members of the original Denig Demons from World War II. (See photo coverage on P-5

Lehrer, who served during the mid-1950s, was a first lieutenant and officer in charge of the BOOT newspaper in an eight month period prior to his discharge in 1958. His editor, then gunnery sergeant Jack Paxton, was given the honor of presenting the award during the luncheon. The two had not seen each other since 1958 but had kept in touch over the years.

During his acceptance speech Lehrer acknowledged the "tribal elders" who perfected the art of combat reporting from World War II onward but also had words of encouragement for the entourage of new officer and enlisted CCs from classes at DINFOS who were in attendance.

Commentary: Paul Shaner

(Ed. Note: We had quite a few emails regarding the death of Paul Shaner. Following are several of them.)

Eddie Evans: From 1960-62, MCAS El Toro was my first duty station out of boot camp, and MSgt. Paul Shaner was often in and out of there. He always carried a swagger stick, was the soul of kindness and the image of a gentleman in Marine green; with his pencil thin mustache he always looked like he just walked off the pages of an illustration of a fashion plate of the "perfect" Marine. At that time the thenconsisted of Maior "Red" Sullivan, Lou Cappazoli, Rip Smith, Bob Springer, Vera Lavalley, Virginia Cruse, Joe Dominguez, Chuck Kester, Ken Maddux, Jim Schwaninger, George Wilson, Jim Keeling, George Webb, Benny Marrufo, Howard Shinrock, Tom Segel, "Big" John McKay, (much bigger) Jim Dorrough, Bob McEwen, a blonde WM Corporal whose name escapes me, and a thin, tall LCpl. from Illinois who was the first monorail driver in the U.S., operating the new one at Disneyland where most of us worked on weekends; also a photographer whose name escapes me. I seem to remember that he and Chuck Kester worked together a lot. Seems like there was also a Capt. Schmidt who went on to become a California congressman. Those were amazing times, the best of times. Since I was just out of recruit training, I thought they had sent me to a different Marine Corps, but then, Marine Corps aviation has always been a little different. MSgt. Paul Shaner was one of the best.

Red Carpenter: The photographer's name was Chuck Tyler and I believe at the time he and Kester were West Coast stringers for Leatherneck Magazine. I knew Paul only after retirement and at USMCCCA conferences. Thought he was a good man and fine Marine. I do remember playing golf with Paul a couple of times and he is the only golfer I ever knew to play golf in cowboy boots with spikes on the bottom

Jim Schwaninger: The Lance Corporal from Illinois was (and probably still is) named **Ted Suter** and he was from Indiana. Ted would

check in at Disneyland with his employee pass, come through the main gate and get his hand stamped, then give me his employee pass so I could get in through the employee gate w/o paying. I would spend the rest of many evenings free-riding on the monorail while Ted worked.



Because you will be reading this in February some events will have been planned. But, if there is something bugging you or something you feel is needed, call us at 352.748.4698 or email us at usmccca@cfl.rr.com. Don O'Neal has already promised there will be something for all—both old timer and current warriors.

You will not see the term, "Early Bird" mentioned in our registration process this year. We are not doing away with the discount, only the name. We are now going to call this a Member-only discount applying to the entire package of events. Obviously, the idea of paying less, might attract new members. Why not try it? The price for the non-member package will be higher as will ala carte pricing for the individual activities.

The registration deadline date will apply to all and will coincide with hotel requirements, e.g., the hotel requires us to give them an accurate count of attendees approximately two weeks in advance of the conference. **We have no control over this requirement**. This also helps us in planning accurate meal counts – which has given conference planners heartburn in the past.

Hotels traditionally ask for accurate meal counts 72 hours prior to each event. If we have accurate registration data we're okay. If we have many last minute walkins, as we did last year, it becomes a guessing game and we stand to lose. Example: For last year's Thursday Awards Banquet, we were required to give an accurate count by Tuesday morning. We knew would get last minute attendees from Camp Pendleton, San Diego and

Miramar but did not know how many. So, we guessed and overestimated by 30 meals. **The guess cost us nearly \$1500.** This year we will have a near-exact count for each meal event through the advance registration process. Late comers will be fed but, it might not be the same thing everyone else gets.

The Menger Hotel will offer the guaranteed room rate of \$112 until July 18. After that date the rate will go up substantially. It will be up to you to get your reservation made prior to that date if you want to stay at the Menger. Last year, because so many waited till the last minute, the conference hotel ran out of the number of negotiated rooms. We had to work with two additional hotels at a higher price to take care of late comers.

Finally, the "early bird" designation for discounted quarter page ads for the Annual Journal is also being changed. This year members will get the discounted rate of \$125 for a black and white ad; \$150 for color. Non-members and businesses wanting the quarter page ads will pay \$150 and \$180, respectively. Members will continue to get a 20% discount on all other sized ads. Ads sold by chapters will continue to get the 20% discount as well. In case you don't get it, we're going after members.

While we hated to see **Fast Eddie Evans** give up his weekly CCFYI that Mo started, we can appreciate that he needed to take a break. He now informs us he is coming out of retirement at the request of his old employer, the Army Corps of Engineers. Good men are hard to find. They found one. We wish him well.

About Overdue Dues & Association Costs

Many of you have received telephone calls from members of our Board reminding you that your dues are overdue and your membership will end by February 15. Many of you have also said you did not know this and why didn't CCHQ send out reminders or invoices?

proximately \$115 in postage. (Print cost: Approximately \$320, depending on number of pages.)

We also mail once a year the **Member Directory** (now in progress). Depending on size, this will also cost us about \$115-150 this year.

Depending on numbers running for the Board of Directors each year, we have a mailing of an absentee ballot and biographical material. This can run about \$115-\$125.

Our postcard reminders about membership dues cost this year \$156 in postage alone. This does not include printing costs which we try to do in house. When members forget and we have to send another postcard mailing as we did in January to about 272 delinquent members this cost was about \$73, again not counting cost of cards or the inhouse printing.

Yes, several of you were sent these cards in error. You can blame either the mail program or the executive director. The latter will accept the blame. Hopefully the matter has been corrected. One thing the January mailing did do is show us that many of you have moved and have not kept CCHQ informed about the address change.

Your organization operates on a virtual shoe-string yet we try to give you the best service possible. We answer emails and telephone calls within 24 hours – sometimes sooner. We try to get your newsletter to you early in the second month of the quarter and we try to fill it with a mix of news, photos, humor (at times) and information that will appeal to all.

We are not mind-readers, however. We do hope you will try and remember when dues are due and get them in so that we don't have to spend money on reminders.

We like to hear from you, especially if you have a story to tell, a photo to share or just want to chew the fat about who's where or what it was like in the "old corps." We especially want to know your correct email and home addresses.

Dateline Iraq: Baghdadi Now Secure

COP BAGHDADI, Iraq – How many Marines does it take to

secure Baghdadi? Last year, it took an entire company. Then, as the situation improved, that number dropped to a platoon. And now, with the onset of 2008, the grand total is zero.

The Marines of 2nd Platoon, Company A, 1st Battalion, 7th Marine Regiment, Regimental Combat Team 2, have completely pulled out of Command Outpost Baghdadi. Fortunately for local citizens, their replacements are already hard at work.

In a monumental step toward Iraqi sovereignty, the Baghdadi Police force has taken sole responsibility of security within the city limits. They are the first to do so in all of Al Anbar Province.

If, however, Baghdadi should need emergency assistance, the Marines of $1^{\rm st}$ Bn, $7^{\rm th}$ Marines, won't be far behind.

"The COP is in the middle of our (area of operation), so we'll still

be in an overwatch capacity," said Douglas. "But they know that one day, we'll be gone. They'll need to be able to do things for themselves." The building itself, upon completion of the new police station, will become host to city council meetings and other functions.

"Many people back home think the Anbar awakening happened overnight," Dill said. "But where we're at today is the culmination of four years worth of hard work and dedication by Marines and Iraqis alike. I want this city to stop looking like it's under siege. This is a huge step toward the return to normalcy."

"In the past, battalions were measured on how many battle positions they established during a deployment," said Lt. Col. J.J. Dill, commanding officer, 1st Bn., 7th Marines. "It showed they were moving out into the community, partnering with (Iraqi Security Forces) to make things happen. But in this stage of the counterinsurgency battle, it's not how many we put up — it's how many we take down."

The transfer of authority comes as a direct result of the Baghdadi IP validation, which is determined by U.S. and coalition forces.

"It's a checklist of where they're at," said Capt. Craig T. Douglas, the company commander of Co. A, 1st Bn., 7th Marines. "Can they run their own investigations, conduct security patrols, etcetera.? Are they self-sufficient?"

With their own battlespace, the Baghdadi IPs face their toughest challenge yet. Can they do it alone?

"The IPs of Baghdadi are ready to take over," Douglas said. "They want the bad guys out of here just as much as we do. With logistical support from the government of Iraq, they should be ok."



This will be the fourth year for the tournament which has grown in popularity and profitability. Originally, a joint venture of the CCs and the Florida Marine Corps League during the first two years, the Chapter decided to go it alone in 2007 and, due to sponsorships, auctions, and player fees, the tournament produced a profit for the CCs of slightly over \$8,000.
