


This is your Foundation. We are proud to serve as the Association's major resource for development and we thank you all for the confidence you have shown in our stewardship of the funds contributed to support association activities.



# **Executive Summary: All Meetings**

## 2013 Old Board Meeting: July 24

President Bill Hauptfleisch called the meeting of the 2013 USMCCCA Board of Directors to order at 8:40 a.m. Present were: Vice President Kate Stark, Secretary Chris Whiting, Directors Angela Mink, Manny Pacheco and Cal Openshaw, and Executive Director Jack Paxton. Foundation Treasurer Carol Rees and Bob McEwen sat in on the meeting. A quorum was present.

### Reports

1. Secretary: Hauptfleisch called on Secretary Whiting to read the minutes of the last meeting. Since the board did not have a quorum for a meeting at the last conference, no minutes were read. Whiting briefed the board on business conducted online over the past year, citing votes on accepting the Treasurer's report from the 2012 conference, filling Hauptfleisch's vacant board seat (Cal Openshaw agreed to serve) and voting on the Denig and Dickson Award recipients.

2. Treasurer's Report: Executive Director Jack Paxton briefed on the Treasurer's report in the absence of Treasurer Rick Lavers. Overall, we are in very good shape. He said he does not know what to predict for this conference, as we had a \$1,100 bill for the bus trips. He said we got three gifts of \$500 each to help with conference expenses and he said he thinks the conference should come out even.

3. Executive Director: Paxton said he would give a complete report at the Annual Business Meeting.

**Old Business** No old business was discussed.

### New Business

Succession: Hauptfleisch asked the status of the Succession Committee. Paxton said he was not sure the committee had met. Director Manny Pacheco recommended tabling this discussion and addressing it at the Annual Business Meeting. He made a motion which was seconded and passed.

Merit Awards: Kate Stark said the Merit Awards program is so successful that it has turned into a nightmare to judge. She said there are now 58 categories in print and broadcast media and she had between 40 and 112 entries per category. She said maybe we should cut it down to just the categories for the Thomas Jefferson Awards. Pacheco told the board that OSD is in the process of revising what services can submit for the TJ Awards and changing the format. He recommended waiting for guidance on these changes before attempting to change our awards program. It was also mentioned that Combat Camera is judging their own categories, so those categories could stay as they are. After some discussion of what categories might be eliminated, Pacheco moved to wait until October 1 for guidance from OSD and DivPA as to the changes to the TJ format and then make a recommendation for the new board to consider. Hauptfleisch appointed Stark to head up the committee to make this recommendation. The motion was seconded, passed and carried.

Conference discussion: Pacheco rehashed some conversation from the night before regarding conferences. He said there was discussion about how the conferences used to be done, including spouse events and lots of fun. He said he feels we should do stuff for the young Marines and work with Div Pa. He said our intent for this conference is not to do what DivPa wants, however, we are here to get the maximum participation for the Merit Awards Banquet. He said there is a feeling that we are being led around on a chain by DivPa, and in some ways that is true. He said he has a beef with the fact that commands are not sending their award recipients to get their recognition. Discussion vielded the fact that we should try to align the 2014 conference with some activity by the active duty component, but that our agenda should not necessarily be driven by theirs. Future conferences need to have a conference chair and program chair who can put together a conference for our members.

Social Media: As a segue from the conference discussion, Mink said she has a presentation on social media. Mink will present this at the Founda-

## tion Board Meeting

**Newsletter:** Paxton said he feels that printing and mailing a quarterly newsletter is a waste of time and money. He said there is no new news coming in and he rehashes content from the website for most of it. He added that we have around 200 honorary life members and he wonders if they ever even read the newsletter. He said it costs \$340 to \$380 a quarter to print it and \$80 to \$90 to mail it. After discussion regarding the value of having a printed newsletter, it was determined that a readership survey should be printed in the next issue to determine if members still want to receive a newsletter in the mail.

**2014 Conference:** Paxton said he has been looking at the way the 1<sup>st</sup> Marine Division Assoc. does its conferences. They use an a la carte format for activities and members can choose which one they want to do. Someone said that can be expensive and works better with more attendees. He said we need to look at a time frame for the 2014 Conference. Pacheco recommended having it near a major military installation and said we would probably have to look at doing this for the next two to three years. Myrtle Beach and the Tidewater area were discussed as possibilities. It was decided to look at proposals from these sites and make a decision in November or December. Pacheco made a motion to hold it in mid-September, 2014 and look at the Tidewater area. The motion was passed.

The meeting adjourned at 10:15 a.m.

## 2013 Foundation Board Meeting: July 24, 2013

Acting Foundation President (Vice President) Tom Kerr called the meeting of the 2013 USMCCCA Foundation to order at 1:10 p.m. Present were: Treasurer Carol Rees, Directors Red Carpenter, Walt Ford, Pat Coulter, Bill Hauptfleisch, Kate Stark, Chris Whiting, Angela Mink, Manny Pacheco and Cal Openshaw and Executive Director Jack Paxton. Brian Thompson was also present. A quorum was present.

## Reports

1. Foundation President: Kerr read a report from Foundation President Don O'Neal, who could not make the conference due to recovering from a successful kidney transplant. O'Neal thanked Kerr for stepping up and running the Foundation in his absence. (Ed. Note: This report is carried in full on P-2 of this issue.).

2. Secretary: Association Secretary Chris Whiting agreed to take the minutes in the absence of Foundation Secretary Sally Pritchett. Kerr called on Whiting to read the minutes of the last meeting. A motion was made to accept the minutes as published in Executive Summary form in the Now Hear This newsletter. The motion was seconded, passed and carried

3. Treasurer's Report: Treasurer Carol Rees said the Foundation is solvent. She said she had previously sent out reports from activity covering December through May. She detailed the accounts saying the Foundation has a total of \$116,410.57, which includes Foundation funds, the Sunshine Fund, and the McPartland and Denig Scholarship Funds. She said she moved \$5000 into CDs from the Denig Scholarship Fund. She said the Sunshine and McPartland Funds are in CDs. The Foundation has \$81,754.96 in available funds. Director Red Carpenter said the Florida Chapter Golf Tournament raised \$7000 and requested it be used as follows: \$4000 to the Semper Fi Fund, \$2000 to the Scholarship Fund, and \$1000 to the Support the Troops Fund. A motion was made to allocate the funds as suggested, it was seconded and passed. As a point of order, Rees explained that the Treasurer's report does not need to be accepted by the board, but she would like to see an audit done, and the results of that audit would then have to be accepted by the board. Kerr said he had an unofficial audit done two years ago and it found our procedures to be correct. Executive Director Jack Paxton recommended an audit be done after Rees' second year as Foundation Treasurer.

4. Scholarship report: Director Walt Ford reported that the Scholarship Committee advertised the availability of scholarships and got two submissions. They are Jennifer Brofer, who received the Denig Scholar-

5. Succession Committee: Carpenter said the Succession Committee asked Ford and Coulter to continue to serve on the Foundation Board. 6. Social Media: Director Angela Mink gave the board a presentation about social media, saying that is it now more powerful than traditional media at reaching an audience. She said it was invented by the "me" generation to foster a sense on community and belonging. She feels we should be marketing our Association and Foundation with social media. Director (webmaster) Kate Stark our organization already has a Facebook page, a group page on Facebook and a Twitter account. She said there are 43 in the Facebook group and 573 people read our posts. Mink went on to outline the different outlets we could be using, saying we can only gain by having a more powerful online presence. Mink suggested forming a committee of tech-savvy members and taking what Stark has begun and building on it. Kerr suggested calling it the Communications Committee.

7. Executive Director: Paxton said he had been asked to provide a job description. He said he has been at the job for eight years and it has evolved, with new stuff coming up every year. Being proactive, he said, was the most important thing. He reported that we gave out \$6000 in scholarships. He said the Booster Club is languishing a bit, but that is not surprising because of the effort to raise funds for the Denig Memorial. He called the Memorial "the most significant thing" the organization has done, as we raised \$43,600, all from members. He said there are still five bricks left to be laid at the Memorial site. He added that he is still "prorating" a \$10,000 gift into the Booster Club. He said the Dedicated Mem-
